Dandridge, 39, a kung fu instructor from Richmond, Va., **Parker, 33, a professional hypnotist from Lansdowne**, and Mazzio, 23, a businessman

from Gladwyne, were convicted of fraud charges yesterday by a U.S. District Court jury. They will be sentenced early next year by Judge Clarence C. Newcomer.

Parker claimed the Cadillac Allante offered in the Trump Drive-In Dreamstakes and received about \$3,000 after Seidman and his partner, Gross, sold the car to a dealership for \$32,000, the prosecutor said. Parker, who tried to cure Seidman's alcohol and drug addiction by hypnosis, also recruited others to claim Jeep Cherokees and Renault GTAs offered in a Georgia Pacific-Coronet Great America Giveaway Game, the prosecutor said.

A professional hypnotist, a kung fu teacher and a former marketing man yesterday each were placed on five years' probation with brief periods of house arrest for helping two area promoters rig nationwide sweepstakes contests.

Senior U.S. District Judge Clarence C. Newcomer also ordered the defendants to make restitution in various amounts totalling \$78,290 to unwary contest sponsors, and each defendant must donate 300 hours of community service.

The hypnotist, James T. Parker Jr., who got \$3,500 to claim a \$50,000 Cadillac Allante in a rigged Trump Plaza Hotel sweepstakes, will have to spend four months under house arrest, the judge said.

Parker, 33, a former Lansdowne resident who now lives in California, also profited from the sales of four Renault sedans and two Jeeps worth a total of \$61,290 that were "won" by others whom Parker had recruited to pose as winners in contests sponsored by Georgia Pacific.
